### **b.) Purposes of processing personal data**

- We only process personal data that we collect directly from you during the membership registration process and your subsequent membership of the association. We process this personal data for the following purposes:

### **c.) Legal basis for the processing of personal data**

The data processing is lawful on the basis of Article 6(1)(f) of the EU's General Data Protection Regulation (GDPR). Our legitimate interest lies primarily in enabling efficient communications between the member and the association. We have a legitimate interest in processing the contact person's name and email address so that we can administer memberships promptly.

### **d.) Recipients or categories of recipient of personal data**

### **e.) Duration of storage**

- Personal data will be stored for the duration of the membership.
- Following termination of the membership, any personal data will be deleted after two years.

### **Your rights under the GDPR:**
